Law of Criminalizing the Normalization with the Zionist Entity

In the name of people Presidency of Rrepublic

Based on what had approved by the Parliament in accordance with the provisions of Item (First) of Article (61) and Item (Third) of Article (73) of the Constitution; the following law was issued:

No.(1) of 2022 Law of Criminalization of Normalizaton with the Zionist Entity

Definitions

Article 1

For the purpose of this law, the following terms shall mean the meanings indicated thereto:



Laws

First: Zionist entity: The Israeli entity that has occupied the territory of the State of Palestine since 1948 or any other Arab territories.

Second: Normalization: Any act that would achieve with the Zionist entity any form of dealing or lead to it, either directly or indirectly, with the aim of establishing a relationship with the Zionist entity.

Aims

Article ٢

This law aims to fulfill the following purpose:

First: Prohibiting and criminalizing normalization with the Zionist entity.

Second: Preventing the establishment of relations with the Zionist entity in any way.

Application Scope

Article ٣

This law shall be applied to:

First: the Iraqi person (natural and legal) inside and outside Iraq.

Second: all Iraqi state institutions and all their federal authorities.

Third: The presidency and governments of the regions in Iraq, their parliamentary councils, the councils of their provinces, their local administrations and all their institutions.

Fourth: Local administrations in Iraq and their not-organized-in-a region councils and all their departments and institutions.

Fifth: Iraqi media operating inside and outside Iraq.

Crimes and Penalties

Article 4

First: Whoever travels to the Zionist entity, visits one of its embassies or institutions all over the world, or communicates with any of them, shall be punished with life or temporary imprisonment.

Second: The provisions of this article shall not apply to religious visits accompanied with the prior approval of the Iraqi Ministry of Interior.

Article 5

Whoever who provides any kind of aid, donations or gifts or accepts any of them from the Zionist entity or its institutions shall be punished with life or temporary imprisonment.

Article 6

Whoever establishes any diplomatic, economic, political, military, security, cultural or any other kind of relationship with the Zionist entity shall be punished with the death penalty or life imprisonment.

Article 7

Whoever normalizes or communicates with the Zionist entity or promotes it or any Zionist or Masonic ideas, principles, ideologies, or behaviors, by any public or secret means, including conferences, gatherings, publications, literature or social media or any other means shall be punished with death or life imprisonment.

Article 8

Whoever belongs to any of the institutions of the Zionist entity shall be punished with death or life imprisonment.

Article 9

If one of the criminal acts stipulated in articles (4, 5, 6, 7, 8) of this law is committed, the penalty shall be death or life imprisonment penalized by the President of Republic, his/ her deputies, the Prime Minister or his/ her deputies, the Speaker of the Parliament or his/ her two deputies, the Head of the Supreme

Judicial Council or his/ her deputies, the Chief Judge of the Federal Supreme Court or his/ her deputy, the Heads of Regions or their deputies, Heads of the Governments of the regions or their deputies, Speakers of Parliaments of the regions or their deputies, Ministers and those of their rank, Members of the Parliament, Ministers of Governments of the regions, Members of Parliaments of the regions, the Heads and Members of the Federal Court of Cassation, the Head and Members of Public Prosecution Service, Head and Members of the Judicial Supreme Board, Members of Federal Court, all Judges, an Undersecretary and those of his/ her rank, General Managers or those of their rank, heads of political parties and entities, members of security and military services, Governors or their deputies, Head and Members of Provincial and Local Councils in the not-organized-in a region provinces or ambassadors.

Article 10

Publications, literature or any other means that promote normalization with the Zionist entity, without prejudice to the criminal responsibility of the perpetrator under this law, shall be confiscated.

Article 11

The provisions of articles of legal excuses and mitigated judicial circumstances stipulated in the Penal Code No. (111) of 1969 amended or any other law shall be applied to anyone who commits one of the crimes stipulated in this law and shall not be covered by any general or special amnesty

Article 12

In case one of the acts stipulated in this law occurs during a state of war, it shall be considered an aggravating circumstance.

Article 13

The foreigner may not promote normalization or to call for the establishment of a relationship with the Zionist entity within Iraqi territory.

Article 14

The provisions of the Penal Law No. (111) of 1969 amended, shall be applied to whatever is not provided for in this law .

Article 15

Any text that violates the provisions of this law shall not be enforced.

Article 16

This law shall be effective from the date of its publication in the Official Gazette.
